



# 2021 Cool Roof Rebate Application

A rebate is available to encourage CPS Energy **residential** customers to install a Cool Roof. Please direct any questions to **210-353-2SAV** or visit CPS Energy website at [www.cpsenergy.com](http://www.cpsenergy.com) for current information on funds availability.

## Instruction and Conditions

- Applications must be completed and submitted within 30 days of installation of the Cool Roof.
- Applications are subject to verification. If the verification cannot be completed, the rebate will not be paid.
- The rebate recipient must be a CPS Energy **residential** electric customer. Commercial customers may apply for a Cool Roof rebate under the Commercial Custom program.
- Please allow 8 to 10 weeks after receipt of all documents for the rebate to appear as a credit on your CPS Energy account.
- Materials purchase and installation date must be from January 1, 2021 to December 31, 2021.
- The rebate is based on the square footage of the conditioned space. This does not include unconditioned space such as patios, porches, garages, breezeways, carports or overhangs. On two story buildings – The lower floor area under the upper story does not add to the total rebate area.
- To be eligible for a rebate, 75% or greater of the roof surface must be replaced with a Cool Roof with no significant shading of the roof. Existing roof must not already have a radiant barrier in place.
- Homes must have functioning electrical air conditioning. Window and central AC are both eligible.

### Rebate Payment Tiers:

- **\$0.08/sq. ft. for projects with reflectance greater than 40%**
- **\$0.20/sq. ft. for projects with reflectance greater than 65%**
